Registration documentation

- Registration documents
 - Scanned copies of the original 12th or 2nd PUC
 - Passport size photograph
 - Identity proof (either of pan card, passport, driving license, Voter ID, Adhaar card 10th mark sheet)
- All documents should be in "jpeg" format in different files with size not exceeding 2 mb
- Details required for registration
 - Full name
 - Date of birth (dd/mm/yyyy)
 - Gender
 - Address with pin code
 - Email id
 - Mobile number
 - Alternate number

Exam entry

- At all levels, Exam can be written at a Pearson Centre
- Three case study exams each at Operational,
 Management and Strategic level are available
 4 times a year February, May, August and
 November
- Case Study Exam Entry and Result Dates As per CIMA website
- No negative marking

- CIMA Diploma in Management Accounting on completion of Operational level (papers E1, F1, P1 & case study exam)
- Advanced CIMA Diploma in Management
 Accounting on completion of Management level
 (papers E2, F2, P2 & case study exam)
- CIMA qualification upon completion of the strategic level (papers E3, F3, P3 & case study exam)
- To gain CIMA membership, 3 year work experience in the relevant areas is required.
