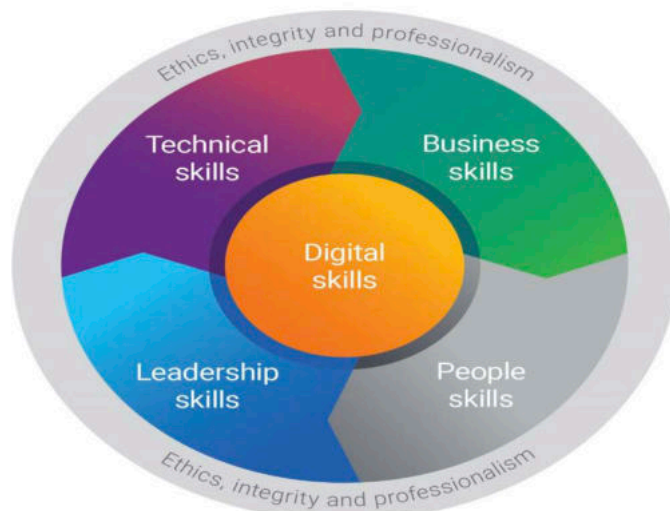

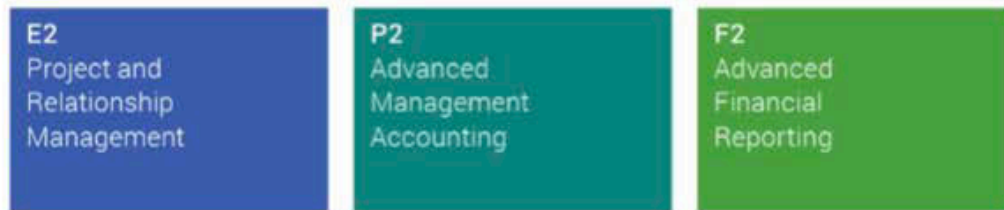

# **LEARNING PATH**

Under the CIMA Finance Leadership Program (FLP), students will be studying the course under 3 levels which are the Operational Level, Management Level and the Strategic Level. Each level consists of 3 subjects belonging to the Enterprise pillar, Performance pillar and Finance pillar respectively.

Registration of the students take place on the CIMA Portal for the FLP Model, further pursuing the first level of the Certification.

## **Operational Level**

Under this level the subjects of study are E1, P1 and F1. Students will be attempting mocks and practice papers based on these subjects in their respective 'My CIMA' portal. Based on the concepts of all the 3 subjects of this level, CIMA releases a Case Study on which the Operational Case Study (OCS) exam is conducted.

Students will be required to give only the OCS Exam under this level and once cleared they are eligible to give exams belonging to the next higher level.

## **Management Level**

Under level the subjects of study are E2, P2 and F2. Students will be attempting mocks and practice papers based on these subjects in their respective 'My CIMA' portal. Based on the concepts of all the 3 subjects of this level, CIMA releases a Case Study on which the Management Case Study (MCS) exam is conducted.

Students will be required to give only the MCS Exam under this level and once cleared they are eligible to give exams belonging to the next higher level.

## **Strategic Level**

Under this level the subjects of study are E3, P3 and F3. Students will be attempting mocks and practice papers based on these subjects in their respective 'My CIMA' portal. Based on the concepts of all the 3 subjects of this level, CIMA releases a Case Study on which the Strategic Case Study (SCS) exam is conducted.

Students will be required to give only the SCS Exam under this level. The next step after clearing it is the Assessment of Practical Experience Requirement.

Assessment of PER. Once the SCS Exam is cleared students are eligible for the Assessment of Practical Experience Requirement (PER) to lead them in to the Membership of the Chartered Institute of Management Accountants (CIMA) and holding the CGMA Designation.

# ADMISSION PROCESS

## ELIGIBILITY

It is mandatory for all candidates seeking admission to the 1st year of the degree programme to have successfully completed 12 years of schooling through an examination conducted by a Board/University. Mandatory eligibility for the Programme is a pass at the +2 level (ISC/CBSE/ other state boards/International Board/Karnataka PU Board) in any stream of Commerce or Science with a minimum of 60%.
