Pursuant to the Government letter No.ED 214 U/NE 2005 dated 1-9-2005 and in exercise of the powers conferred under section 64 of the UGE Act 2000, the Bangalore University hereby accords Autonomous status to St. Joseph's College of Commerce, Bangalore up to the academic year 2009-10 for the following course; and subject to the following conditions:-

Course	Combinations	Intake
B.Com	Bachelor of Commerce	120
B.B.M	Bachelor of Business Management	90
M.Com	Master of Commerce	35

Conditions:-

1. It is only academic autonomy.
2. It applies only to the courses existing at the time of granting autonomy.
3. Autonomous college shall continue to implement the policy of the State Government in all matters including reservation both in the admission of students and recruitment of staff.
4. Since the academic year has commenced the curriculum for the 1st year students need not be changed of this year (2005-06).
5. The College shall strictly follow the Statutes of Autonomous Colleges, regulations of the University of 2000.
6. Intake of students shall not exceed the number fixed by the University.
7. College have to remit Admission, Affiliation, Registration, Sports, NSS, UESGA, processing, Eligibility (National/Foreign national candidates) fees and other fees to University as fixed by the University from time to time.
8. College will have to pay the annual fee/COMED amount as prescribed by the University. The actual fee amounts will be informed to the college in due course.




