**Academic Year 2015-16**

**Research Workshop**

- The Research Department of St. Joseph's College of Commerce organized a workshop on 18<sup>th</sup> August, 2015 for the students of the Travel and Tourism Department. The workshop focused on the basics of researching and on the Research process of collecting, tabulating, analyzing, validating and presentation of information on various segments of Research work.
